How we determined to which students and how much Emergency Financial Aid Grant to award:

Based upon the amount the Department of Education allotted each institution, we used the EFC resulting from completion of the federal financial aid FAFSA for the 2020-21 financial aid award year to determine Emergency Financial Aid Grant eligibility. Students with an EFC of 5,711 or less and eligible for Federal Pell Grant funds were awarded a tier 1 grant; those with an EFC greater than 5,711 or no EFC, but eligible to complete a FAFSA, a tier 2 grant.
